



## **CEPP LA MISSION REOPENING PLAN**

For some time, the CEPP La Mission team has been working in collaboration with the La Mission school to ensure a safe return to school in keeping with the norms imposed by Children's Services as well as Alberta Health Services.

The CEPP team is very excited to welcome your child and guide them on their learning journey. Despite the frequently changing information from the government, our employees, in collaboration with the agents of the FPFA, have built a secure reopening plan.

### **Out-of-School Care Program**

In order to re-adapt the children, ease them back into a routine and allow them to familiarize themselves with the routines and educators, the week of August 31<sup>st</sup> to September 4<sup>th</sup> will be back to school as usual.

Geneviève, your coordinator, will ask you for your child's approximate schedule. You must indicate if your child will be present in the morning and the afternoon, or only at either one, with hours of arrival in the morning and hours of departure in the afternoon.

Know that the educators will only be able to intake one child at a time into the centre and that parents must wait outside. An educator will oversee intakes and departures. During intake, they will take your child's temperature. Please keep in mind that you must anticipate that dropping off your child in the morning will take approximately 10-15 minutes.

### **Gradual Reopening**

As the school is offering a gradual reopening to children according to their last name, we expect to receive your child only on days they are expected to be in school between August 31<sup>st</sup> and September 3<sup>rd</sup>. If your child is absent from the service for this week, please inform the center coordinator.

*\*Please note that though reopening is gradual, service fees will be at the regular rate.*

## **Hours**

In order to respect the arrival of the school's children as well as bus departures, we ask you to respect the following hours for picking up and dropping off your child:

<b>Program</b>	<b>Morning</b>	<b>Evening</b>
Out-of-school care	Between 7 and 8 am	Before 3 pm OR from 4-6 pm

\*Please do not use the bus drop-off parking spaces, and park in front of the school in the designated areas.

## **Doors**

The door that will be used by families as well as the group to enter and exit will be the school's main front door. Parents will not be admitted to the centre.

*\*Parents will not be able to pass through the school's interior to collect their child if they are outside. A sign will be posted on the front door and you will have to go around the school on the outside to go pick up your child.*

## **Outdoor Activities**

Please note that the team will attempt to spend time outside as often as possible with the children, weather permitting. The children will use the school's green space.

No children from any program will be allowed to play on the playground structures.

You will not be able to pass through the school if your child is outside. You must go around the outside of the school.

## **Restrooms**

Restrooms will be used as often as possible in cohorts, following the schedule.

Evidently, if children need to use the restroom outside of scheduled times, they will be allowed to go one child at a time.

## **Wearing Masks**

It is not mandatory for the educators to wear a mask, but they will have to wear one. To follow the rules put in place by the *Conseil Scolaire Centre-Nord*, children in the out-of-school program from kindergarten to Grade 6 must wear a mask at all times inside and outside the school.

*\*Please note, your child must have their own mask and an extra in case of need.*

## **The Cohorts**

The cohorts must not exceed 30 people in total, in accordance with the maximum number of children possible specified in your centre's license. There will never be more than 25 children in the program as well as 2 educators.

For the moment, we have 25 children registered.

## **Sanitation**

In order to respect the strictest sanitation protocols, three educators will ensure ratios at all times. As soon as the ratio allows for it, one of the educators will be charged with ensuring sanitization protocols are followed.

The children as well as the educators will be required to wash their hands several times a day.

## **Communicating with the Team**

Evidently, since you will not be able to come into the classroom, you will not have access to converse with all the members of the team. Your coordinator will therefore establish a method for efficient communication between you and the team in order to provide a follow-up on the day and your child's growth. More details will be communicated with you on this subject as soon as possible.

## **Communication/Concerns**
